NNPHI Public Health Improvement Webinar: Kentucky's Accreditation and QI Support from Within

The Kentucky Health Department Association has long supported public health accreditation and QI. As part of a strategic planning retreat in 2010, the Accreditation Coordinators Workgroup was established. Since then, the workgroup has met regularly to provide support, training, and other communication to Kentucky health departments. With help from the workgroup, six Kentucky health departments have achieved Public Health Accreditation Board accreditation status, and several more departments are in the process of attaining it.

PHF Seeks Opportunities to Pilot New Oral Health Driver Diagram

In September 2013, the Office of Disease Prevention and Health Promotion in the U.S. Department of Health and Human Services funded PHF to develop the <u>Population Health Driver Diagram to Increase Use of Oral</u> <u>Health Care</u>. When working with public health and health care groups in a community, this tool can be used as a framework to help align strategies to increase use of oral health care and to address other common health challenges.

participants with practical skills and promising practices to create quality online training products with the guidance of mentors from CDC. Participants will create an e-learning product based on the knowledge and skills gained throughout the program and will present their product at a final showcase. MAPP Training Scholarship Launched

MAPP is excited to offer scholarships to a training in January. MAPP trainings cover all six phases of the community health improvement planning process and incorporate principles of health equity, accreditation preparation, and effective evaluation. If you are interested in learning the basics (or getting a refresher), consider applying to attend the training for free!



To qualify for a MAPP training scholarship, applicants must be from a local, state, tribal, or territorial health department OR a Health Resources and Services Administration (HRSA)-

funded grantee or health center. The scholarship covers the MAPP training registration fee (\$1,500 for NACCHO members, \$2,000 for nonmember health departments, and \$3,000 for all others) and does NOT include travel and lodging. Scholarship recipients will be responsible for travel, lodging, and all other travel-related expenses. NACCHO staff will evaluate and score all applications based on need and content.

Deadline: All Oakland, California, MAPP training scholarship applications are due **by 5:00 p.m. ET on Friday, October 31, 2014**. For questions, please e-mail <u>mapp@naccho.org</u>.
