Preparing for Accreditation through Evidence-Based Interventions



The National Association of County and City Health Officials (NACCHO) and CDC's Community Guide Branch would like

to announce the launch of <u>The Community Guide - Public Health Accreditation Board</u> <u>Crosswalk</u>. The Community Guide - PHAB Crosswalk is a tool to help health departments identify evidence-based interventions from The Community Guide whose implementation could help document conformity with PHAB domains, standards, and measures.

As a companion tool, the <u>NACCHO Model Practices-Community Guide Crosswalk: A</u> <u>Resource for Implementing Effective Public Health Strategies</u>, can inform LHDs as they consider ways to address public health concerns with effective strategies. The crosswalk identifies NACCHO Model Practices implemented by LHDs along with related recommendations from The Community Guide to help LHDs enhance their practice-based initiatives with evidence, while simultaneously providing examples of ways LHDs can translate evidence into practice in their jurisdictions.

Journal of Public Health Management and Practice

The 20th anniversary issue of the *Journal of Public Health Management and Practice* was published online recently, and it focuses on accreditation. It is being offered with free access in advance of the print edition on the journal's <u>Website</u>. PHAB coordinated the special issue, with support from CDC.
